

Dear Contestant:

Thanks for your interest in the 4th Annual ***Cajun Hot Sauce Festival*** Queen's Pageant. The interview and pageant will be held on Saturday, March 15, 2008 at the Sliman Theatre on Main Street in New Iberia. Contestants are responsible to make their own arrangements for travel and lodging.

Practice (not mandatory) will take place on Friday, March 14th at 6:00pm. Dress is casual and you can bring your shoes to practice. Practice will be kept to a minimal due to all divisions practicing. Also note there will be NO practice on Saturday prior to the pageant.

Interviews will begin with our Junior Division (13-15 year olds) arriving at 10:45am, Teen Division (16-17 year olds) arriving at 11:30am and Miss Division (18-23 year olds) at 12:15am. Contestants will be interviewed for 5 minutes by each judge. Evening wear competition will begin at 5:00pm. Each contestant must prepare an introduction. (90 seconds maximum time)

If you participate in photogenic, you must include your picture with your application. This competition will be judged prior to the pageant. You will be able to pick up the picture for the interviews. Please do not send larger than 5x7.

The application form consists of two pages. Please review the Queen's Agreement prior to mailing your form. EACH QUEEN AND PARENT MUST SIGN THE QUEEN'S AGREEMENT FOLLOWING THE CEREMONY.

Our festival dates are Friday, April 4th thru Sunday, April 6th at the Sugarena in New Iberia. You must spend the weekend with us. A schedule of introduction times will be sent to you prior to the weekend so you can prepare to be on time. Friday & Saturday night, dress is casual with crown & banner. On Sunday, you must report to the Sugarena for noon and expect to be there until 5:00pm. Dress for Sunday is casual and festival T-shirt, which will be given to you.

Cajun Hot Sauce Queen Agreement

Upon acceptance of the title of *Miss Cajun Hot Sauce Queen*, *Teen Cajun Hot Sauce Queen* and *Junior Cajun Hot Sauce Queen* let it be known that it is an honor, responsibility and commitment for one year to represent the *Cajun Hot Sauce Festival* at various functions.

- I agree that I am between the ages of 18-23 for the Miss Division, 16-17 for the Teen Division and 13-15 for the Junior Division (by March 15th), a resident of the State of Louisiana, never been married, nor had a child.
- I agree to spend the 1st full weekend in April participating at the *Cajun Hot Sauce Festival*.
- I agree to be courteous, conduct myself in a lady like manner at all times.
- I agree not to consume alcohol or smoke while representing the *Cajun Hot Sauce Festival*. Removal of crown and banner while attending a festival does not exempt me from my responsibility.
- I agree not to compete for any other title during my reign except for LAFF Queen of Queens. At this time I DO NOT hold a title of any sort. I will ONLY wear the crown & banner awarded to me.
- I agree to report plans for travel to the directors upon my response to each festival and have an adult over the age of 21 accompany me at all times unless approved by the directors. I will be under the direct supervision of the pageant directors.
- I agree to allow the *Cajun Hot Sauce Festival* to use my information and photographs to promote the festival.
- I agree the *Cajun Hot Sauce Festival* is not responsible for loss of personal belonging, accidents or illnesses during my travels.
- (Miss Queen Only) I agree to take the best care of the crown, scepter, banners and train & mantle. If any damage occurs during my reign I must notify the directors and I am responsible for the repair cost. I CAN NOT repair any of the items myself or hire someone to repair them for me. The replacement cost of the crown is \$1,800.00, the cost of the banners is \$150.00 and the train & mantle is \$1,000.00.
- (Junior & Teen Queen Only) I agree to take the best care of the crown & banner. If any damage occurs during my reign I must notify the directors and I am responsible for the repair cost. I CAN NOT repair any of the items myself or hire someone to repair them for me. The replacement cost of the crown & banner is \$250.00. This crown becomes your possession after the reign is completed.
- (Miss Queen Only) I agree to keep all receipts for travel & postage pertaining to my travels while representing the *Cajun Hot Sauce Festival*. Mileage logs must be completed along with receipts. This must be turned in to the Pageant Directors every month. I understand that reimbursement will be based on the Board's discretion.
- I agree to attend no less than twelve (12), at least four (4) LAFF Festivals per quarter (April-June, July-September, October-December & January-March). In addition I agree to participate in Sugar Cane Festival (Parade), Louisiana Cattle Festival, Erath's 4th of July & Delcambre Shrimp Festival.
- Above rules will be monitored on a monthly basis and contract breakage will NOT be tolerated!

If at anytime the above agreement is broken I agree to forfeit the title crown, banner & gifts. All property & awards must be returned to the *Cajun Hot Sauce Festival*. *The Cajun Hot Sauce Festival Board* has the right to determine anyone ineligible.
